DEFINITIONS

CoinDesk Bitcoin Trend Indicator Futures Index	The Underlying Index systematically and dynamically allocates between (i) U.S. exchange-traded bitcoin futures contracts ("Bitcoin Futures"), and (ii) the Global X 1-3 Month T-Bill ETF (the "U.S. Treasury ETF"), a passively managed exchange-traded fund ("ETF") and affiliate of the Fund. The Underlying Index allocates between these two exposures based on the value of the Bitcoin Trend Indicator (the "Signal"), a dynamic quantitative signal developed and administrated by CoinDesk Indices, Inc. (the "Index Provider") which aims to detect the presence, direction, and strength of the price trend in bitcoin. The Signal seeks to achieve this using a combination of four exponential moving average calculations, which compute the average price of bitcoin over explicit periods and are then combined into a single value.
