

DEFINITIONS

Global X U.S. Cash Flow Kings 100 Index

The Underlying Index is designed to provide exposure to large- and mid-capitalization U.S. equity securities that exhibit high free cash flow yields relative to the eligible universe of companies, as determined by the Index Administrator.

(1) Free cash flow is the cash a company generates after accounting for operating and capital expenditures. Free cash flow yield is defined as a company's free cash flow per share, divided by its enterprise value per share.

NAVs are calculated using prices as of 4:00 PM Eastern Time. Indices are unmanaged and do not include the effect of fees, expenses or sales charges. One cannot invest directly in an index.

Since the Fund's shares did not trade in the secondary market until several days after the Fund's inception, for the period from inception to the first day of secondary market trading in Shares, the NAV of the Fund is used to calculate market returns.
