SOLACTIVE GBS UNITED STATES 500 INDEX

SELECTION

- The Solactive GBS United States 500 Index is designed to track the performance of the largest 500 companies that are listed on U.S. exchanges and traded in U.S. dollars.
- First, all companies that are part of the Solactive GBS United States Investable Universe Index are eligible for inclusion.
- At each rebalance, all eligible securities are ranked in descending order by total market capitalization. Securities ranked 1 through 425 are selected for inclusion in the Index. Existing Index constituents ranked between 426 and 600 are then added in rank order until the Index contains 500 companies. If fewer than 500 companies are selected, the highest-ranking remaining eligible securities are added in rank order until the Index reaches 500 companies.

WEIGHTING SCHEME

- The index is free float market capitalization weighted.

REBALANCING

- The index rebalances on a quarterly basis, effective after market close on the first Wednesday in February, May, August, and November.
